

- 20. Enter the total cost of the selling units in the **Case Cost** field.
- 21. The **Weight UOM** will default to pounds and should remain as the default.
- 22. Enter the total weight of the case in the **Gross Weight** field.
- 23. The Case Height, Case Width, and Case Depth fields are not required but if you know them you should enter them.
- 24. Cube UOM will default and should remain as **Cubic Foot.**
- 25. Enter the cube of the case in the **Cube** field. The cube of the case is calculated as cube height x cube width x cube depth divided by 1728.
- 26. If you negotiated a Buy Minimum and Buy Multiple other than 1 with your buyer, enter them in these fields. If you did not, leave them at 1.
- 27. Enter the **TI** and **HI** in the next fields if applicable.
- 28. If the cases of your product have inner packs, and the intention is for the Meijer Distribution Facility to open up the case and slot the inner packs separately, enter the number of inners for your case in the **Inner Pack** field. If not, leave the default as 1.
