


# **JOB AIDS**

#### **SUBSIDIARIES**

- Excluding real estate, there are currently 5 subsidiaries
  - Domestic (US)
    - 1. Advantus: company with majority of the activity
    - 2. OP Products: consignment company
      - Not owned by Advantus
  - International
    - 3. Hangzhou Trading: China entity trading company
    - 4. Total Design: Hong Kong trading company
    - 5. DM Creations: Hong Kong trading company
    - All international entities are owned by Advantus

#### **NETSUITE STRUCTURE**


- OneWorld account
- Account set up with parent subsidiary of CORP
- In subsidiary dropdowns, you will see CORP : Advantus for Advantus
  - Colon symbol indicate a parent-child relationship
- The subsidiary for every record and transaction is listed on the form
- Access to subsidiaries is role-based
  - Not all roles will have access
  - If your role needs permission to a subsidiary, request a permission update from IT Support
- Keep an eye on the reporting being used
  - May need to be updated to limit based on subsidiary or expand for additional subsidiaries







• Standard sales transactions are much simpler than the consignment process





#### **OVERVIEW**


- Why?
  - In most states, stocking inventory in the state creates nexus (connection between taxpayer and state)
  - We are required to pay taxes in states where we have nexus
- Holds ownership of consignment inventory until product is sold to end user
- In 1.0, Accounting did the majority of the transactions due to the system limitations
- In 2.0, the appropriate departments will manage the setup and process the transactions
- In the past, OP Products has had several customers
  - Dormant until now
- Artistic acquisition includes consignment inventory with Staples
- OP Products only includes domestic consignment

























# **SETUPS**

- Department responsible setup in Advantus will be responsible for setup in OP
- Types\*
  - Items
  - Locations
  - Customers
  - Pricing
  - Purchase Contracts
  - Vendors
  - Partners

\*Note: not a comprehensive list

#### **SETUPS: ITEMS**

- An item record is used across subsidiaries
- Subsidiaries can be added after the item is setup
- Subsidiary selection can be viewed on the Development tab of the item record
- Record owner: Product & Sourcing



# **SETUPS: LOCATIONS**

- Subsidiary-specific
- OP Product's locations are not binned
- Subsidiary selection can be viewed at the top of the location record
- Record owner: IT



# **SETUPS: CUSTOMERS**

- Subsidiary-specific
- OP Products is an Advantus customer
- Subsidiary selection can be viewed in the Classification section of the customer record
- Record owner: Customer Service

# **SETUPS: PRICING AND PURCHASE CONTRACTS**

#### Pricing

- Pricing is set on the OP customer (Advantus subsidiary) and Staples customer (OP subsidiary)
  - OP's price is the price to Staples
  - Advantus' price is the price to OP
- Record owner: Sales Admin and Marketing
- Purchase Contracts
  - OP cost based on Advantus price
  - Record owner: Product & Sourcing

### **SETUPS: VENDORS**

- A vendor can be used across subsidiaries
- Subsidiary selection can be viewed on the Subsidiaries sublist on the Details subtab of the vendor record
- Record owner: Accounting

# **SETUPS: PARTNERS**

- Subsidiary-specific
- Subsidiary selection can be viewed in the Classification section of the partner record
- Record owner: Accounting



#### TRANSACTIONS

- Initially all of the transactions will be done manually
  - There is some built-in functionality that will be implemented over time
- Subsidiary is set on every transaction
- The department who processes the transaction in Advantus will process them in OP
- Types of transactions
  - Purchase Orders: SCM
  - Item Receipts: SCM
  - Vendor Bills: Accounting (A/P)
  - Bill Payment: Accounting (A/P)
  - Invoices: Accounting (A/R)
  - Customer Payment: Accounting (A/R)
